

NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257

AND PARAGRAPH 1 OF SCHEDULE 14

AMBER VALLEY (BRIDLEWAY NO. 65 - PARISH OF HEANOR AND LOSCOE)

PUBLIC BRIDLEWAY DIVERSION ORDER 2020

The above order was made on 1 July 2020. The effect of the order will be to divert the whole width of Bridleway No. 65 in the Parish of Heanor and Loscoe commencing at Point A (Grid Reference SK42574 47403) proceeding in a Southwest direction to Point B (SK42553 47382) for a distance of 29 metres or thereabouts. Thereafter from Point B (Grid Reference SK42553 47382) proceeding in a Southeast direction to Point C (SK42564 47371) for a distance of 16 metres or thereabouts. Continuing from Point C (Grid Reference SK42564 47371) proceeding in a Southwest direction to Point D (SK42544 47347) for a distance of 30 metres or thereabouts. Thereafter from Point D (Grid reference SK42544 47347) proceeding in a south south-east direction to Point E (SK42546 47333) for a distance of 14 metres or thereabouts.

The alternative footpath will commence from Point G (Grid Reference SK42573 47392) proceeding in a Southwest direction to Point F (SK42573 47393) for a distance of 68 metres or thereabouts. Continuing from Point F (Grid Reference SK42529 47352) proceeding in a southeast direction to Point E (SK42546 47333) for a distance of 25 metres or thereabouts as shown on the order map.

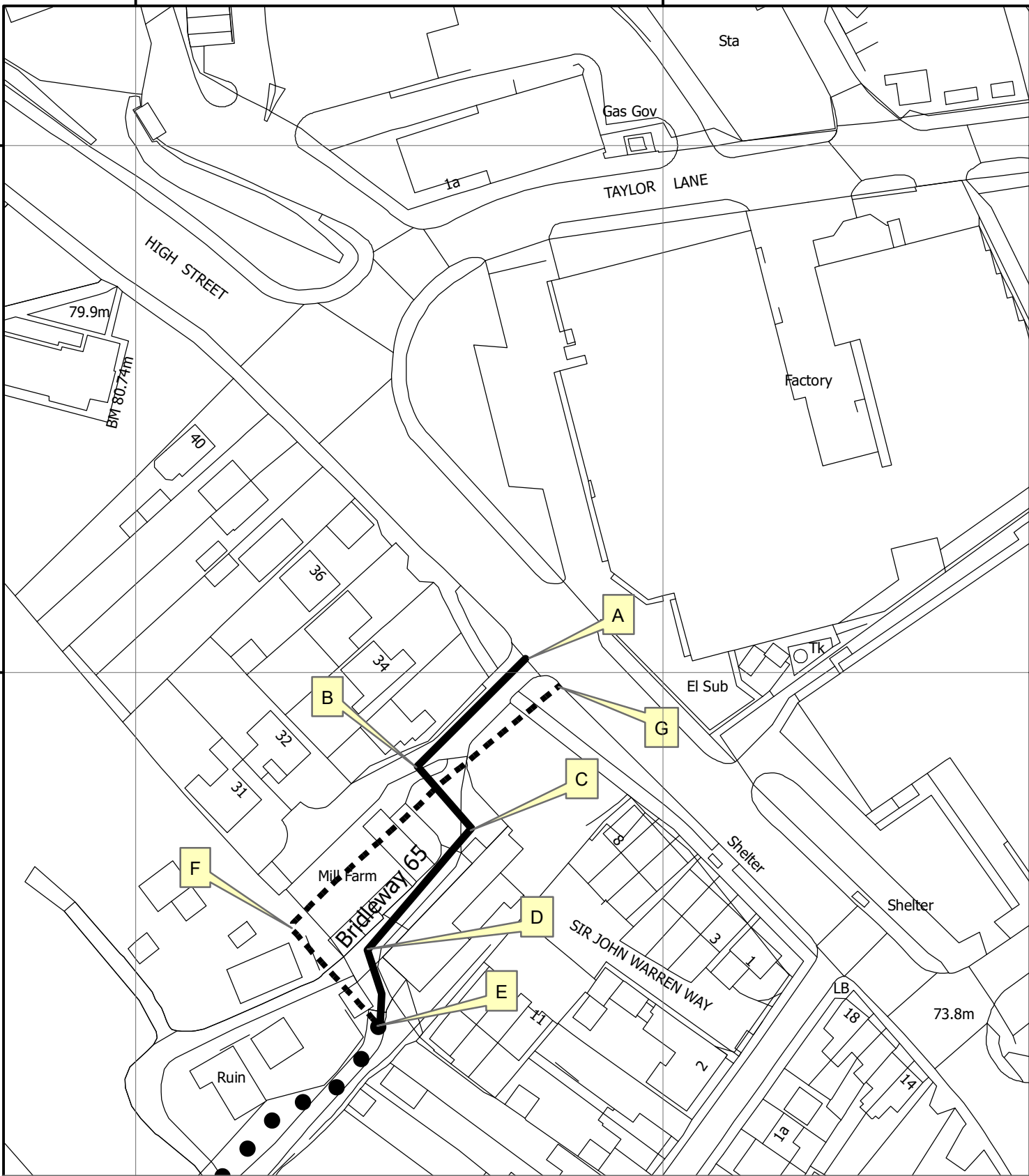

If the order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations or objections which have not been withdrawn will be sent with the order.
