

## HER MAJESTY THE QUEEN'S 70<sup>th</sup> YEAR PLATINUM JUBILEE

### STREET CLOSURES AND STREET PARTIES

Her Majesty the Queen will celebrate her 70<sup>th</sup> year as monarch in 2022. Consequently, celebrations will take place on Thursday 2<sup>nd</sup> June 2022– Sunday 5 June 2022.

Many residents of the Borough may wish to hold street parties on those dates to celebrate the Queen's Jubilee.

Should you wish to organise a Summer Fete or Street Party please read the following guidance information.

#### Street Closures

Amber Valley Borough Council intends to make one or more temporary road closure orders pursuant to its powers under the Town Police Clauses Act 1847 on Monday 23<sup>rd</sup> May 2022 or shortly afterwards.

The Council will be consulting the Police, Derbyshire County Council (the Highway Authority) and other statutory undertakers and consequently the Council would appreciate as much notice as possible of any requests for street closures.

To enable the consultations to take place applications should be made **before Monday 25 April 2022**

The Council will not be making a charge for processing applications for street closures in connection with Her Majesty the Queen's 70th Jubilee celebrations.

#### Licensing Act 2003 requirements

You should not normally need to apply to the Council for a Temporary Events Notice if any performance at your street party/fete is incidental or background, including recorded music.

If you are publicising a programme of bands etc. or are selling things like entrance tickets or alcohol you would need to apply for a Temporary Event Notice at least 10 working days prior to your event. Please note these days do not include weekends, bank holidays, the day of service or the day of the event.

The last date you may submit a Temporary Event Notice for a Jubilee celebration event is 18 May 2022. Two copies should be forwarded to the Council, together with the £21.00 fee and one copy to the Licensing Department, Chesterfield Police

Station, Beetwell Street, Chesterfield, S40 1QP. Please note that the fee is set nationally and the Council does not have the power to waive it. The Council is required by law to reject late notices.
