

**AMBER VALLEY BOROUGH COUNCIL**

**CRICH PARISH NEIGHBOURHOOD PLAN**

**FINAL DECISION STATEMENT**

**1. Summary**

- 1.1 Following the result of the Referendum on 6 September 2018, Amber Valley Borough Council formally 'made' the Crich Parish Neighbourhood Plan on 19 September 2018.
- 1.2 The Crich Parish Neighbourhood Plan now forms part of the Development Plan for Amber Valley, in relation to the Parish of Crich.
- 1.3 The Borough Council is publishing its decision to 'make' the Crich Parish Neighbourhood Plan in accordance with Regulation 19 of the Town and Country Planning (Neighbourhood Plan) (General) Regulations 2012 (as amended).

**2. Background**

- 2.1 On 12 February 2015, Amber Valley Borough Council designated Crich Parish as a Neighbourhood Area, for the purpose of preparing a Neighbourhood Plan in accordance with the Town and Country Planning (England), Neighbourhood Planning (General) Regulations 2012.
- 2.2 The qualifying body, Crich Parish Council, invited representations on a draft Neighbourhood Plan between 20 March 2017 and 1 May 2017. The draft Neighbourhood Plan was subsequently formally submitted to the Borough Council on the 14 September 2017. The submitted Plan was then publicised on 22 September 2018 and representations invited within a 6-week period, which ended on 3 November 2017.
- 2.3 Following consultation with the Parish Council, the Borough Council appointed an independent Examiner, Mr Richard High, to carry out an examination of the Plan. The Examiner concluded that certain modifications to the submitted Crich Parish Neighbourhood Plan were required in order to meet the 'basic conditions', as set out in Paragraph 8(2) of schedule 4B to the Town and Country Planning Act 1990, as applied to Neighbourhood Plans by section 38A of the Planning and Compulsory Purchase Act 2004.

- 2.4 An Executive Decision was made on 27 July 2018, confirming that the Crich Parish Neighbourhood Plan, with the recommended modifications, meets the 'basic conditions', as required by Paragraph 12 of Schedule 4B to the Town and Country Planning Act 1990.
- 2.5 The Executive Decision resolved to approve arrangements for the holding of a Referendum in relation to the modified Plan, authorising the Borough Council's Executive Director (Resources) to finalise the date and detailed arrangements for the Referendum, in consultation with the Leader and relevant Cabinet Members and that the electoral area for the Referendum shall be the Parish of Crich (Crich Ward and part of the Wingfield Ward) and not be extended beyond that area.
- 2.6 The date for the Referendum was subsequently agreed as 6 September 2018.
- 2.7 The result of the Referendum, in relation to the following question:

*'Do you want Amber Valley Borough Council to use the Neighbourhood Plan for Crich to help it decide planning applications in the neighbourhood area?'*

was as follows:-

- Number of votes cast in favour of a 'Yes'                      1,094 (97%)
- Number of votes cast in favour of a 'No'                        29 (3%)
- Number of ballot papers rejected                                    1

### **3 Decision and Reasons**

- 3.1 At the meeting of the Borough Council's Cabinet on 19 September 2018, the Cabinet was advised that as the number of votes in the Referendum cast in favour of a 'Yes' constituted more than half of those voting (i.e. 50% plus 1), it must 'make' the Crich Parish Neighbourhood Plan as soon as reasonably practical. The Cabinet was also advised that, in accordance with Regulation 19 of the Neighbourhood Plan (General) Regulations 2012 (as amended), the Borough Council would need to publicise its decision and the reasons for the decision (the 'decision statement') and details of where and when the 'decision statement' can be inspected, as well as sending a copy of the 'decision statement' to Crich Parish Council and to any person(s) who asked to be notified of the decision.
- 3.2 The Borough Council's Cabinet therefore resolved on 19 September 2018 that the Crich Parish Neighbourhood Plan be formerly 'made' and forms part of the Development Plan and be used in the determination of planning applications for the Parish of Crich.
- 3.3 With the Examiner's recommended modifications, the Crich Parish Neighbourhood Plan meets the 'basic conditions' set out in paragraph 8(2) of

the Schedule 4B of the Town and Country Planning Act 1990, is compatible with EU obligations and the Convention rights and complies with relevant provision made by or under Section 38A and B of the Planning and Compulsory Purchase Act 2004, as amended.

- 3.4 The Borough Council has assessed that the Crich Parish Neighbourhood Plan, including its preparation, does not breach and would not otherwise be incompatible with any EU obligation or any of the Convention rights (within the meaning of the Human Rights Act 1998).
